About the Role: As a Security Guard at ECCL, you will be responsible for maintaining a safe and secure environment for employees, visitors, and company assets. This role requires a high level of integrity, alertness, and adherence to security protocols.

Key Responsibilities:

- Monitor and authorize entrance and departure of employees, visitors, and other persons to guard against theft and maintain security of premises.
- Patrol premises regularly to prevent and detect signs of intrusion and ensure security of doors, windows, and gates.
- Respond to alarms and investigate disturbances.

Requirements:

- Valid certificate of good conduct from the Directorate of Criminal Investigations (DCI) is mandatory. Additional security training (e.g., First Aid, Fire Safety, counter-terrorism awareness) is a significant advantage.

- Communication Skills: Excellent verbal and written communication skills in English and Kiswahili.
